Key responsibilities and accountabilities:	<ul style="list-style-type: none">• Pick up and deliver products, supplies, and equipment and run errands as directed by the Assistant Operations Managers.• Maintain and preserve records associated with product pick up and deliveries.• Ensure all loads are secure and that securing devices are in good condition prior to transporting.• Perform pre and post vehicle inspections to validate that the vehicle is in a safe operable condition and submit to management.• Complete and submit driver logs to management in a timely manner.• Maintain the company vehicle by renewing inspection tags, licenses, and performing preventive maintenance as required and submit to management.• Notify the Operations Manager of any issues identified with the company vehicle and/or issues surrounding deliveries/operations.• Perform work and drive the company truck in a safe manner including adherence to driving laws and company safe practices.• Inform the Operations Manager of any driving violations, tickets, and incidents that occur.• Perform housekeeping and other general warehouse maintenance activities as required.• Maintain a current driver's license at the appropriate classification level.• Maintain a current commercial driver medical certification on file with the company.• Maintain a safe driving record and be knowledgeable of all FMCSA regulations.• Performs other tasks and assists in special projects as per supervisor's request.• Facilitate the development of system documents such as operating procedures and work instructions that are needed in the fields operation area.
